-Hosted UK Department of Energy and Climate change scientists for an on the ground investigation of the wood pellet industry.
-Reached hundreds of thousands of individuals through the release of a biomass infographic.
-Developed coalitions of conservation organizations in Louisiana and North Carolina.
-Initiated an effort that generated over 5000 comments to the NC Ports Authority opposing Enviva Export facility.
